# NOTIFICATION

## "Ummid"

1. Short Title and commencement:

- (i) This Scheme shall be called "Ummid"
- (ii) The scheme shall come into force from the date of publication in the Official Gazette.
- 2. Objective

The scheme "Ummid" is giving hope to the Senior Citizens in the present system that the Government is taking care for their old age requirement.

Following are the main objectives of scheme:-

- (I) To provide their daily required things like hearing and vision testing and supply aids, spectacles and walking aids.
- (II) For keeping good physical and mental health "day care centre".
- 3. Target Group
  - (I) All the citizens having the age 60 or above who are residents of Goa for the last 15 years.
  - (II) Their income shall not exceed to Rs.60,000/- per annum.

# 4. Identification of beneficiaries

 Village Panchayats & Municipalities shall keep basic Data of all the target groups. This shall be updated every six months. The list of the beneficiaries shall be placed in the Gram Sabha (in case of Village Panchayat)/Municipal Council for approval. (ii) The approved list of beneficiaries shall be displayed on the V.P./wiunicipal Council notice board for the information of the general public.

(iii) Any objection in respect of the final list shall be submitted to the Director of Social Welfare who after hearing all the concerned shall dispose the objection. The decision of the Director of Social Welfare shall be final.

#### 5. Day Care Centres "Ummid"

The Government shall provide financial assistance to the local self Government for establishment of Day Care Centre. Initially day care centres shall start in the Municipal area and in the Village Panchayat having its 11 members.

The Local Self Government is required to provide accommodation having minimum 2 rooms (having an area 25 sq. meters each) on the ground floor with facility of toilet and bath room. Preference shall be given near the library. Rooms shall have appropriate ventilation, electricity and drinking water facility. There shall be one full time attendant for 10 enrolled members.

In any above mentioned area in case any Non Government organizations express its willingness to run or start the Day Care Centre Ummid on the consent of the V.P/Municipal Council as the case may be permission may be grant to the N.G.O. However in the "B" and "C" type of the Municipality and V.P. there shall be only one centre.

Application for sanction of day care centre shall be in Proforma "A".

6. Financial Assistance

The state Government shall provide following grants-in-the-first-year-andsubsequent years on satisfaction of the audit team constituted by the Government for this regard.

1- Installation grants Rs.30,000/- (Rupees Thirty thousand only)

- a. Purchase of T.V./Radio Rs.10,000/- (one-time in first year).
- b. Furniture grants Rs. 20,000/- (one time in first year)
- 2- Regular Grants Rs.1,10,000/- (Rupees One lakh ten thousand only) per annum)
  - a. Salary of the attendant @ Rs.2500/- p.m. (R.30, 000/- p.a.)
  - b. News papers/periodicals grant @ Rs.5000/-p.a.
    - c. Electricity / Water Supply charges @ Rs: 500/-p.m. (Rs.6000/p.a.)
  - d. Telephone charges @ Rs.300/-,p.m. (Rs.3600/-,p.a.)
    - e. Sweeping / cleaning charges @ 1500/- p.m. (Rs. 18000/- p.a.)
  - f. Miscellaneous charges @ Rs.5000/- p.a.

g. Providing light refreshment / tea to the members @ Rs.3000/p.m. per 10 members.( Rs.36,000/-p.a)

h. Rent of the premises @ Rs.500/- p.m. or actual which ever is

7. Release of Grants

The installation grants shall be released one time only in the first year while sanctioning the day Caré centre under "Ummid"Recurring grants shall be released in two installments. 1<sup>st</sup> installment of 50% at the starting and 2<sup>nd</sup> installment of 50% shall be released on utilization of installation grants and 50% of 1<sup>st</sup> installment of recurring grants.

The Local Self Government or NGO as the case may be is required to maintain a separate bank account of he grants received under this scheme. They are required to submit audited statement duly audited by the Registered Chartered Accountant and supported by the Utilization Certificate.

Subsequent year 1<sup>st</sup> installment i.e.50% of the recurring grants shall be released in the month of April. 2<sup>nd</sup> installment shall be released on submission of Audited report of the previous year and utilization certificate of entire amount of previous year and50% of the 1<sup>st</sup> installment of the current year.

 Free hearing and vision testing and supply aids, spectacles and walking aids:

The State Government twice in a year shall organize free medical checkup in the day care centres, while giving 15 days notice in advance with the assistance of the Goa Medical College Hospital and Directorate of Health Services or any other Non Government Organization. As per the advice given by the Doctors the Government shall provide following aids to the target group:

- b. Spectacles
- c. Waking stick

9. Health Check-up

Every 1<sup>st</sup> & 16<sup>th</sup> of the month there shall be Free clinical test for BP & diabetes. After the test the local self Government or NGO as the case may be assist the member for appropriate treatment with the assistance of nearest hospital. The member of Day care Centre "Ummid" shall be given preference in all the hospitals of the state.

10. Timing of day care centre "Ummid"

Day Care Centre "Ummid" shall remain open every day from 10.00 A.M.till 6.00 P.M.

#### 11. Other facility in the Centre

There shall be one daily local, one national news paper and two periodicals. Everyday at about 4.00 P.M. light refreshment and tea shall be provided.

6.2(h) Rent of premises occupied by Day Care Centre for Senior Citizen by NGO's is to be paid in the following manner.

(a) Rs. 2,500/- p.m. or actual rent fixed by PWD whichever is less in rural areas.

(b) Rs. 5,000/- p.m. of actual rent fixed by PWD whichever is less in urban areas.

the Indian Stamp Act, 1899 (Act 2 of 1899), as in force in the State of Goa, read with section 21 of the General Clauses Act, 1897 (10 of 1897), the Government of Goa hereby further amends the Government Order No. 35/4/2016-RD dated 30-03-2017, published in the Official Gazette, Extraordinary, Series I No. 52 dated 30-03-2017 (hereinafter referred to as the "principal Order") as follows, namely:—

In the principal Order,-

(1) after clause (i), the following clause shall be inserted, namely:---

"[*ia*] reduces the stamp duty chargeable on conveyance such as a Deed of Conveyance or Deed of Sale or Deed of Transfer executed in pursuance of an Agreement or Memorandum of Understanding executed on or before 31-03-2014 in respect of,—

(i) a plot of land of an area not exceeding 600 square meters where the occupancy certificate also has been obtained after completion of construction on such plot of land on or before the said date; or

(ii) a dwelling unit having built up area not exceeding 200 square meters,

(not being a transfer charged or exempted under article No. 62), which is presently specified in article 22(b) of Schedule I-A of the said Act, to the scale of one percent of the present market value of the property, for a period of three months with effect from the 1st day of May, 2023;";

(II) for clause (ii), the following clause shall be substituted, namely:----

"(*ii*) reduces the stamp duty chargeable on conveyance (not being a transfer charged or exempted under article No. 62) so far as it relates to immovable property, which is presently specified in article 22(*b*) of Schedule I-A of the said Act, executed by or on behalf of the co-operative housing society which has been registered under the Goa Co-operative Societies Act, 2001 (Goa Act 36 of 2001) on or before 31-03-2014, to the scale of one percent of the present market value of the property, for a period of three months with effect from the 1st day of May, 2023;".

This order shall come into force on the 1st day of May, 2023.

Clause 5 Day Care Centre "Ummid": The following shall be replaced:

2. NGOs registered under Society Act/ /Trust/Village Panchayat/Municipalities may apply in the prescribed Performa 'A'.

#### SERIES I No. 4

2. The premises in which Ummid Centre will be established should have basic facilities such as proper sitting room having minimum 25 sq. mt. area with proper toilet facility proper light and fan arrangement drinking of water facility etc. There should be at least one full time attendant.

*Clause 6 Financial Assistance*: The following shall be added:

2. (d) Telephone/Mobile Charges.

(h) Rent of the premises to be claimed on the production of rent payment certificate.

Clause 8 Free hearing and vision testing and supply aids, spectacles and walking aids: The following shall be replaced:

NGOs registered under Society Act/Trust/ /Village Panchayats/Municipalities may organize camps with the help of Government hospitals/Private hospitals/sponsors for providing free hearing aid, spectacles, walking aids, etc.

*Clause 9 Health check-up*: The following shall be replaced:

NGOs registered under Society Act/Trust/ /Village Panchayat/Municipalities may organize Health check up with the help of Government hospitals/Private hospitals/ /Sponsors.

*Clause 13 Relaxation*: The following shall be added:

Government may modify the scheme or some of the changes of the scheme if required.

The following draft regulations which the Government of Goa proposes to make in exercise of the powers conferred by subsections (1) and (2) of section 4 of the Goa (Regulation of Land Development and Building Construction) Act, 2008 (Goa Act 6 of 2008) so as to further amend the Goa Land Development and Building Construction Regulations, 2010, are hereby pre-published as required by section 5 of the said Act, for information of all the persons likely to be affected thereby and notice is hereby given that the said draft regulations will be taken into consideration by the Government after expiry of a period of 30 days from the date of publication of this Notification in the Official Gazette.

All objections and/or suggestions to the said draft Regulations may be forwarded to the Chief Town Planner (Administration), Town and Country Planning Department, 2nd Floor, Dempo Tower, Patto Plaza, Panaji, Goa, before the expiry of the said period of 30 days so that they may be taken into consideration at the time of finalization of the said draft Regulations.

#### DRAFT REGULATIONS

In exercise of the powers conferred by sub-sections (1) and (2) of section 4 of the Goa (Regulation of Land Development and Building Construction) Act, 2008 (Goa Act 6 of 2008) and all other powers enabling it in this behalf, the Government of Goa hereby makes the following regulations so as to further amend the Goa Land Development and Building Construction Regulations, 2010, namely:—

1. Short title and commencement.— (1) These regulations may be called the Goa Land Development and Building Construction (Amendment) Regulations, 2023.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Amendment of regulation 2.— In regulation 2 of the Goa Land Development and Building Construction Regulations, 2010 (hereinafter referred to as the "principal Regulations"),—
