**ORDER**

The Grantee institution shall submit the Utilization Certificate within the period of Six Month from the date of sanction. The subsequent installment of grants shall be released only after receipt of utilization certificate for the grants released for the previous period.

The expenditure of **Rs.88,177/-** (Rupees Eighty Eight Thousand One Hundred Seventy Seven only) to **“Kreeda Sanskrutik Shrujanatmak, Goa Rajya, Nivrutt Karmachari mandal”** Assonora, Bicholim, Goa, shall be debited under Demand No:57 to the Budget Head of accounts “2235–Social Security and Welfare, 02–Social Welfare, 104-Welfare of Aged, Infirm and destitute, 05–Ummid–Day Care Centre, and Medical Assistance to Sr. Citizens, 31–Grant-in-aid.
