ORDER


Sanction of the Government is hereby conveyed for an amount of Rs.2,00,000/- (Rupees Two Lakhs only) to “UDANT” Little Abodes, Block D, Flat No. DF-2, St. Augustine Morod, St. Cruz, Goa towards release of 1<sup>st</sup> installment for the year 2024-25 for the Project to empower weaker sections, including women, children, and marginalized communities, through education, skill development, healthcare, and economic opportunities for fostering a more inclusive and thriving society at Indiranagar, Chimbel from 1<sup>st</sup> August 2024 to 31<sup>st</sup> August 2025 under the Scheme “MUKHYAMANTRI SAHAYATA NIDHI YOJANA” notified under Notification No. 83/12/2023-24-SDB/MSNY/7397 dated 25<sup>th</sup> January 2024.

The expenditure shall be debited under **Demand No:57** under the Budget Head of Accounts “**2235- Social Security and Welfare; 02-Social Welfare, 200-Other Programme; 21-Mukhyamantri Sahayata Nidhi to NGO’s; 00-General, 31-Grant-in-Aid**”.

The amount sanctioned under this scheme shall be utilized for the purpose for which it has been sanctioned within a period of 15 days from the date of proposed activities. The utilization Certificate as per GFR-12-A and the proof of 20% contribution by NGO with detailed account in this regard and a report on the conduct of such activity along with photographs shall be submitted to the Director of Social Welfare.
